Sick child	Fever, Sneezing, Coughing, feeling ill, looking pale, Sweaty /chills	High	<b>Immediately isolate child and call parent/guardian to collect child as soon as possible.</b> Take child's temperature every half hour and record on Incident report form. Ensure child is comfortable and hydrated, cool child down with cool, damp towel if child's temperature is rising. If temperature goes up to 40 degrees, call an ambulance and then inform parents of this (if parents have not collected child).	All educators, Educational Leader, Centre Director	Hazard identified
Sick staff	Fever, Sneezing, Coughing, feeling ill, looking pale, Sweaty/chills	High	Educator requested to do a RAT as soon as possible and advise management of the result. If positive, staff to be informed to go home as soon as possible. Staff to stay away from centre until symptoms abate.	Centre Director, Educational Leader	Hazard identified

Sick parent/family member	Fever, Sneezing, Coughing, feeling ill, looking pale, Sweaty/chills	High	Parent/Family member encouraged not to come on site if unwell and to get someone else to collect child.	All educators, Educational Leader, Centre Director	Hazard Identified
Staff:Child Ratios	Unable to meet staff to child ratios during illness	High	Ensure educator to inform of illness the day before their shift or as soon as possible once they become ill. Centre Director to report to regulatory body and to request a waiver on ratios.	Centre Director	During sessions
All children and staff	Possibility of being ill in near future from touching surfaces, close contact with ill people	High	All staff and children to follow correct handwashing procedures before entering premises and after exiting premises.  Handwashing must be done before/after eating, after toileting and before preparing /serving food. Handwashing must be done regularly during the day.  Posters and signs have all been placed inside and outside the service.	All educators, Educational Leader, Centre Director to monitor and supervise	Before, During and After Activities
All families/visitors	Possibility of being ill in near future, touching surfaces, close contact with ill people	High	All families/visitors to follow correct handwashing procedures before entering and exiting the premises.
